SPECIFIC CONDITIONS ORDERED BY COURT:

GENERAL CONDITIONS OF SUPERVISION (General Order, date: 9/21/95 effective 1/1/96, revised 2/1/11, revised 4/1/16, revised 1/25/21)

- 1.) Report to your Probation Officer as directed. Complete the written report form accurately and completely.

- 2.) Upon reporting to the Probation Department and when in Court you shall conduct yourself in an orderly manner.
- 3.) Pay all fines, court costs, restitution, and Court approved fees in regular monthly installments as directed.
- 4.) Submit as directed to random drug and/or alcohol testing. Comply with the Trumbull County Adult Probation Department Drug Testing Policy and Procedures. Submit to evaluation and/or treatment for substance abuse, mental health or other problems. Take medication, as prescribed to you by your health care professional or doctor, for any of these problems. Sign an authorization releasing to the Probation Department any information regarding these evaluations and/or treatment programs. All prescriptions must be verified by the Probation Department. You are prohibited from using any illegal drugs or mood or mind altering substances.
- 5.) Inform your Probation Officer immediately of any changes in your residence, contact phone number, employment, or source of income.
- 6.) Do not associate with persons having known criminal records (including convicted co-defendants, or anyone on probation or parole, unless granted permission). You are prohibited from acting as an informant for any law enforcement agency without the permission of the Judge or your Probation Officer.
- 7.) Do not purchase, use, possess, have access to, or carry a firearm.
- 8.) Do not leave your County or State of residence without permission from your Probation Officer.
- 9.) Obey all local, state, and federal laws and be of good behavior. Report any new arrests immediately to your Probation Officer.
- 10.) You hereby waive your Fourth Amendment rights and agree to submit to search and seizure by the Probation Department or law enforcement officer working in conjunction with the Probation Department of your person, property, vehicle, residence and personal effects, including cell phone(s), as well as any other property or area under your control, at any time, with or without a search warrant, arrest warrant or reasonable cause.
- 11.) You shall not frequent certain areas that are designated off limits by the Adult Probation Department, including any government housing (such as Trumbull Metropolitan Housing), unless otherwise granted permission.

I hereby acknowledge that I have read (or had read to me) the above conditions of supervision. I understand these conditions and received a copy of them. Until such terms are modified, they shall remain in effect as written above. I further understand that failing to comply with one or more of the above conditions of supervision may result in my arrest, a probation violation hearing, and imposition of a jail or prison sentence.

I was further advised that should I abscond, which includes failing to report to my Probation Officer, leaving the jurisdiction without obtaining permission from the Court or my Probation Officer, or being confined in any institution for the commission of any offense while under community control, the term of community control will be tolled until I am brought before the Court. This will extend the termination (end) date of my community control by the length of time that I absconded and subject to the maximum five year term permissible by law pursuant to R.C. 2929.15(A)(1).
